# ASSUMPTION OF RISK, VOLUNTARY RELEASE, AND INDEMNITY AGREEMENT

In consideration for being permitted to participate in the ministry activities being held at **Vacation Bible School**, Splash Kingdom, in Canton, Texas, from August 10-12, 2009 (herein referred to as the "Ministry Event") and any activities conducted during early arrivals and extended departures, the undersigned, \_\_\_\_\_ (herein referred to as the "Participant"), agrees as follows:

1. ASSUMPTION OF RISK AND REPRESENTATION. The Participant understands, is aware of, and assumes all risks inherent in participating in water activities. These risks include, but are not limited to, tube floating, swimming, and other water related activities. Such activities may result in serious bodily injury or death. The Participant represents that he/she possesses the necessary skills and fitness to Participate in these activities safely and without supervision.

2. RELEASE WAIVER, DISCHARGE AND COVENANT NOT TO SUE. The Participant and/or his or her personal representatives, assignees, insurer, heirs, executors, administrators, spouse and next of kin, hereby releases, waives, discharges and covenants not to sue LAKESIDE BAPTIST CHURCH, a Texas nonprofit corporation, herein referred to as "CHURCH"), and its directors, officers, employees, agents, volunteers as well as its successors, assigns, affiliates, subordinates, and subsidiaries; and releases, waives and/or discharges all of the above from any and all liability to its assigns, insurers, heirs, executors, administrators, spouses and next of kin for any and all loss, damage, or cost on account of injury to the Participant or his or her property, whether caused by sole or concurrent negligence of the church, or otherwise, while the Participant is participating in the ministry event and any other activities in connection therewith.

3. INDEMNITY. The Participant agrees to indemnify CHURCH from any liability, loss, damage or cost that may incur due to the participation by the Participant in the Ministry Event whether caused by the negligence of CHURCH, or otherwise, while participating in the ministry event.

4. MANDATORY ARBITRATION. The parties agree that any claim or dispute arising from or related to this Agreement shall be settled by biblically based mediation and, if necessary, legally binding arbitration in accordance with the Rules of Procedure for Christian Conciliation of the Institute for Christian Conciliation, a division of Peacemaker® Ministries (complete text of the Rules is available at [www.HisPeace.org](http://www.HisPeace.org) or there is a copy on file in the office of Lakeside Baptist Church). Judgment upon an arbitration decision may be entered in any court otherwise having jurisdiction. The parties understand that these methods shall be the sole remedy for any controversy or claim arising out of this Agreement and expressly waive their right to file a lawsuit in any civil court against one another for such disputes, except to enforce an arbitration decision.

The Participant expressly agrees that this Assumption of Risk, Voluntary Release, and Indemnity Agreement (herein referred to as the "Agreement"), is intended to be as broad and inclusive as permitted by the laws of the State of Texas and that, if any portion of this Agreement is held invalid, it is agreed that the balance, notwithstanding, shall continue in full legal force and effect.

5. I grant to Lakeside Baptist Church, its representatives and employees the right to take photographs of me and my property in connection with the above-identified subject/activity. I authorize Lakeside Baptist Church, its assignees and transferees to copyright, use and publish the same in print and/or electronically. I agree that Lakeside Baptist Church may use such photographs of me with or without my name and for any lawful purpose, including for example such purposes as publicity, illustration, advertising, and Web content.

- I HAVE CAREFULLY READ THIS AGREEMENT.

- I UNDERSTAND THAT I ASSUME ALL RISKS INHERENT IN THE MINISTRY EVENT SET FORTH IN THIS AGREEMENT.

- I UNDERSTAND THAT THIS AGREEMENT IS A RELEASE OF ALL CLAIMS, INCLUDING THE NEGLIGENCE OF CHURCH.

- I UNDERSTAND THAT I AM INDEMNIFYING CHURCH.

- I CERTIFY THAT I AM THE LEGAL GUARDIAN ACTING ON BEHALF OF THE PARTICIPANT WHO IS UNDER THE AGE OF EIGHTEEN (18) YEARS OLD.

- I VOLUNTARILY SIGN MY NAME EVIDENCING MY UNDERSTANDING AND ACCEPTANCE OF THE PROVISIONS OF THIS AGREEMENT.
